Throughout November 2020, we have continued our rural crime campaign and a number of farms have been visited and provided free information packs in addition to vital information sharing between the farmers and Police. We now have some Selecta DNA packs that we are able to provide, which are an effective prevention measure to reducing Acquisitive crime. As we move into December, Police Scotland have launched their Annual Festive Drink / Drug Campaign and we encourage members of the community to report anyone who they believe to be driving under the influence of drugs or alcohol. This can be done via 999 if it is ongoing, 101 or alternatively Crimestoppers. Anyone reporting this can request to remain anonymous.

Protecting most vulnerable

In November 2020 Police in the Scottish Borders attended and were involved with around 112 mental health related calls and around 24 missing person enquiries and approximately 64 Domestic related incidents.

East Berwickshire had 6 mental health related calls and 1 missing person enquiry. Due to GDPR and protection of victims/subjects involved, we are unable to share any more specific information in relation to these type of call within this report.

Police Scotland work in collaboration with key partners to assist the most vulnerable within the communities and to provide support.



Reducing Violence and Anti-Social Behaviour

Assaults

On 05/11/2020 report of Juvenile assaulted at Eyemouth High school. Enquires continuing

On 05/11/2020 report of female assaulted in Coldingham High Street. Enquires continuing

On 06/11/2020 report of two males assaulted in Renton Terrace Eyemouth. Youth assailant charged and reported to youth offending team.

On 11/11/2020 report of female assaulted in Queens Road Eyemouth. Assailant traced arrested charged and held in custody for court.

Anti-Social Behaviour

On 02/11/2020 a report of youths throwing eggs at the caravan park in Eyemouth. No damage.

On 05/11/2020 a report of youths with fireworks in Chirnside. No trace of the youths on Police attendance.

On 21/11/2020 report of hare coursing in the Auchencrow area, 3 males traced, no evidence of hare coursing but males issued with Covid Antisocial Behaviour Fixed Penalty Notice tickets for travelling from Tier 3 area to Tier 2.

On 21/11/2020 Scottish Borders Community Action Team were on patrol and heard youths at Eyemouth Primary School. Youths vacated on seeing the police, alcohol was left behind and seized by Police.

Improving Road Safety

Within the Jedburgh Sheriff Court Jurisdiction there were 76 parking tickets issued in November.

On 01/11/2020 a male was charged with having no insurance in Eyemouth after a number of anonymous reports from a member of the public.

On 02/11/2020 a male was charged with driving whilst his licence was revoked near to Cockburnspath and his car was seized.

03/11/2020 report of Eyemouth resident driving a motor vehicle without a valid licence. Vehicle traced and driver charged with driving unaccompanied on a provisional licence further charges to libel against owner of vehicle.

11/11/2020 report of vehicle being struck in the Eyemouth area and driver failing to stop. Enquires ongoing.

11/11/2020 a conditional offer issued to a driver in Allanton for having no MOT.

12/11/2020 report of vehicle being driven in the Chirnside area without a valid MOT certificate. Vehicle traced and driver charged with having NO MOT.

16/11/2020 a conditional offer issued to a driver in Eyemouth for having no MOT.

18/11/2020 a driver was charged with driving whilst using a mobile phone and having no MOT near to Burnmouth.

19/11/2020 a driver was charged in Eyemouth for having no drivers licence and expired MOT. The vehicle was uplifted.

On 24/11/2020 a driver's vehicle was uplifted for having no insurance near to Cockburnspath. The driver and passenger were charged with other road traffic offences.



Tackling Serious and Organised Crime

Operation Hawkeye

The main purpose of the Group (Operation Hawkeye) is to target those transient criminals for whom the borders of Divisions and Forces do not matter.

There have been several high value thefts of Plant and Agricultural Machinery in England which have been recovered in Scotland also English SOCG's coming to Scotland, stealing Plant and using it to force ATM's. Through cross border cooperation it has resulted those responsible being jailed for a number of years.

The operation concentrates on the real time sharing of information regarding the theft of Quad Bikes, Plant, Tractors and other machinery was imperative to assist the Scottish Borders and other areas in targeting key nominals. This is linked with the Rural Crime prevention initiative.

There have been a number of Misuse of Drugs Act warrants executed by the Scottish Borders Community Action Team, who have successfully seized cash and drugs from a number of addresses

European Arrest Warrant

A Polish male was arrested in the Scottish Borders. He was wanted on a European arrest warrant which was issued on 2018 following his conviction for being in possession of cannabis. He was convicted in 2009 in Poland, however he fled Poland and had been living in Scotland since 2015, avoiding and evading authorities knowing he was wanted. Local officers traced the male and he was arrested.

There have been a number of high value telephone, email and online scams, claiming to be banks, HMRC, DWP, Health Board, telephone or broadband to name a few. They appear very plausible, however a social media message has been shared which includes the details of where to report incidents and prevent others being scammed.

Campaigns



With the clocks going back, it's another reminder that winter is coming. This can mean changes to road conditions which can affect everybody from pedestrians and cyclists to motorists. As daylight hours change and the weather becomes more unpredictable, Police Scotland is here throughout to keep people safe.

Chief Superintendent Louise Blakelock said: "Keeping people safe on our roads is a priority for us throughout the year, however as we head into the winter months it is important to ensure vehicles and drivers are prepared for the change in road conditions.

"I would encourage drivers to check their vehicles before we experience the first of the wintry conditions. Some simple steps can be taken to prepare such as checking lights on vehicles to make sure they are in good working order, ensure tyres have sufficient tread, check windscreen washer fluid levels and look out scrapers for clearing frost and ice from your vehicle.

"As the nights get darker, I would also ask pedestrians, cyclists and horse riders to ensure they are visible to other road users.

"More best practice for road users this winter will be highlighted over the coming week as part of our winter road safety campaign."

Mobile CCTV

In partnership with Scottish Borders Council, Mobile CCTV cameras can be deployed across the Scottish Borders in response to significant ASB / crime.

Rural Acquisitive Crime

Our rural acquisitive crime campaign continues focussing on farm theft prevention. Approximately 40 prevention packs have now been delivered to farms by Community Teams. Forensic DNA marking kits and signage, enabled by community partnership funding, have been received and distribution to farms across the Scottish Borders by Community Policing Team Officers has begun.

No Cold Calling Zones

We continue to promote the uptake and refreshment of No Cold Calling Zones across the Scottish Borders.

CAT Update:

SBCAT continue to respond and take a partnership approach to reported incidents of unauthorised off road motorcycles in the Monynut area of Berwickshire. Recent action involved sending letters to the registered keepers of vehicles parked in the area over recent weekends. This process appears to have seen a reduction of motorcycles attending in the area. Further planned partnership activity is to be undertaken.



Youth Patrols – CAT activity for youth patrols have focused on Kelso, Peebles, Eyemouth, Selkirk and Hawick. CAT officers have engaged with youths, seized alcohol and as a result of activity in October a number ASB letters have been sent to the parents of those youths identified as involved in ASB across the region.

CAT have executed a number of MDA warrants across the region recovering a substantial amount of Class A, B and C controlled drugs. During the execution of a MDA warrant in Hawick, £1980 in cash was seized along with a Class B drugs with a potential street value of £3150. During the execution of a warrant in the Peebles, Class B drugs with an approximate street value £700 along with £3442 in cash and £1080 in counterfeit currency. Cat have further executed MDA warrants in Galashiels, Kelso, Peebles and Hawick with recoveries of both Cash and controlled substances.
